

PROGRAM ACTIVITIES

The year 2023 was a time of serious restructuring of the Russian International Affairs Council's (RIAC) substantive work. On the one hand, such changes were dictated by large-scale shifts in the international arena and the emergence of new conceptual frameworks for Russia's foreign policy. On the other hand, they were determined by analyzing the Council's experience over the past twelve years. The task was to adapt RIAC's activities to the world's new conditions, while retaining areas and developments that have previously proved highly efficient.

RIAC continues to prioritize research and academic support for Russian governmental agencies, as well as the consolidation of Russian university and think tank efforts towards international relations. Over the past twelve years, the Council has established itself as a major source of international expertise, as well as an "assembly point" for advanced international relations achievements, coupled with the experience of those working in government agencies, public and private companies, as well as leading media and public organizations.

Additionally, RIAC carries out many of its more traditional activities - preparing analytical documents in various formats, organizing and holding major international conferences, seminars, roundtables, lectures by Russian and foreign experts, as well as many other events. The Council actively uses these formats to conduct a multifaceted analysis of current international issues, develop a dialogue with foreign partners, and promote Russia's approach to solving international problems abroad and domestically. These events are designed to open up new opportunities and mechanisms for cooperation with a wide range of states in the Asia-Pacific and Middle East, in addition to Africa and Latin America, the new associated directions for Russia's future development.

In 2023, activities focusing on Eurasian economic integration rose to a new level in terms of quality. RIAC actively cooperates with the Eurasian Economic Commission. A key achievement was RIAC's ability to organize regular expert seminars on the sidelines of the Eurasian Intergovernmen-

tal Council. To clarify the positions and interests of the EAEU member states, RIAC held numerous bilateral meetings with EAEU member state think tanks. Particularly, a productive exchange took place with the Belarusian Institute for Strategic Studies (BISI) and the Kazakhstan Institute for Strategic Studies (KISI). Contacts were regularly maintained with other partner organizations in Belarus, Armenia and Kyrgyzstan.

Collaboration with Chinese and Indian research centers, institutes and think tanks has also intensified. Promoting Moscow and Beijing's common interest in the global arena, Russian-Chinese economic cooperation and interaction in various regions of the world remained important, as per tradition. Special emphasis was placed on developing logistics and transportation cooperation between Greater Eurasian states, including in the context of growing cooperation between the Eurasian Economic Union (EAEU) and the Belt and Road Initiative (BRI). Such is most relevant, given the ongoing redistribution of global production and supply chains.

While engaging with Indian think tanks, RIAC sought to diversify its links and topics for discussion. In addition to its key partner, the Indian Council on World Affairs (ICWA), a high level of joint work has been accomplished with the Gateway House research center (Mumbai) on global economic and energy issues, as well as with Synergia Foundation (Bangalore) on technological cooperation.

RIAC has also actively supported Russia-Africa summits. A series of analytical materials were prepared and posted on the Council's website and numerous research seminars were held as part of the event.

RIAC activities in Latin America have also intensified. A series of expert seminars and consultations were held with the region's public officials from individual countries. This included coordinating work with multilateral institutions (primarily BRICS) and developing trade and economic relations with the region's countries in the new geopolitical environment.

Studying key regional political and economic trends has been prioritized in RIAC's Middle East

track. To inquire into the current regional dynamics and the views of other players involved in the Middle East, RIAC has held several expert discussions with partner organizations from Iran, Turkey, Syria and China, as well as several research seminars.

In all the above-mentioned areas, work has been carried out in close cooperation with experts from specialized Russian institutions and think tanks, including institutes, the Moscow State Institute of International Relations under the Russian Ministry of Foreign Affairs, St. Petersburg State University, Immanuel Kant Baltic Federal University, Tomsk State University, Lomonosov Northern (Arctic) Federal University, and others. Such successful cooperation is exemplified by a series of joint methodological seminars with the Institute of World Economy and International Relations, Russian Academy of Sciences (IMEMO RAS), as well as with the World Economy and International Relations journal (ME&IR), all aiming to explore currents problems pertaining to international relations.

Some cross-cutting substantive topics that received special attention in 2023 include sanctions, the climate agenda's political dimension, the international dimension of technology-related policies, nuclear weapons and technology, migration policy, promising areas of scientific cooperation between Russia and BRICS nations, developing public diplomacy in Russian regions, and digitally promoting Russian education and research in foreign markets.

Significant emphasis was placed on strengthening the Council's informational presence in the public space, both in Russia and abroad. RIAC organized numerous events via *Urbi et Orbi* City Breakfasts, targeting a wide audience. RIAC con-

tinued to expand its podcast projects and has participated in the annual non/fiction book fair, presenting its past year's publications.

In 2023, the Russian International Affairs Council confirmed its status as one of the most recognizable and authoritative sources of information pertaining to international relations and Russia's foreign policy. RIAC maintains stable partnerships with leading Russian media outlets and regularly holds press conferences and roundtables, involving RIAC members and experts on specific areas, in addition to pressing issues that are on the top of the international agenda at venues such as Russia Today INA, Izvestiya INC, Interfax, Sputnik and others. The Council also has continued its close cooperation with leading Russian news agencies: Russia Today, Izvestiya, and others.

RIAC members and partners are active in providing expert commentary on the most widely read and prestigious online publications, newspapers, news agencies, and often serve as guests on TV and radio programs.

RIAC's website continues to be RIAC's main tool in presenting RIAC-related information. Statistically, the website's views increased significantly in 2023, with a 70% growth year-on-year. The average monthly audience has exceeded 2.5 million users.

Rapid changes in the international environment pose new challenges to RIAC in terms of its further development. RIAC is searching for new areas and formats of work as well as partners in Russia and abroad. The key goal is to conduct an unbiased analysis of world politics and international relations and increase foreign audience trust towards Russia.





RUSSIA'S FOREIGN POLICY IN EURASIA: OPPORTUNITIES FOR DEVELOPING COOPERATION BETWEEN RUSSIA AND EAEU MEMBER STATES

Developing integration processes in the Eurasian space in 2023 was marked by Russia's Eurasian Economic Union (EAEU) chairmanship.


Ambitious tasks such as updating the EAEU's Strategic Development Guidelines until 2025 and intensifying free trade zone agreement negotiations with key partners in the non-Western world – Iran, Indonesia, the United Arab Emirates, and Egypt – were put forward. Special attention was placed on expanding the Roadmap for the Development of Trade and Economic Cooperation between the EAEU and the People's Republic of China (PRC).

In 2023, Eurasian issues occupied a central role in RIAC's programs and activities. Thematic research projects were organized around the priorities put forward by Russia's EAEU chairman. During the year, RIAC Report No. 84/2023 "EAEU Development 2022+: Strategic Challenges and

Imperatives of Our Time" continued to be discussed at various venues. As a follow-up to its main provisions, experts were invited to assess the possibility of deepening parallel integration and the expansion of the Union's external partnerships to identify associated risks and prioritize issues. The prospects for free trade zones on relevant negotiation tracks were analyzed separately in Working Paper No. 83/2023 "Proactive vs Reactive: Interim Results of the EAEU Foreign Economic Policy".

To clarify the positions and interests of EAEU member states, RIAC held various bilateral meetings with leading EAEU member state think tanks – particularly, with the Belarusian Institute for Strategic Studies and the Kazakhstan Institute for Strategic Studies. Contacts are maintained with several partner organizations in Belarus, Armenia and Kyrgyzstan.





Various projects have been developed in close cooperation with specialized agencies. For example, RIAC's draft proposals on the preparation of a new EAEU strategic plan were submitted to the Russian Ministry of Economic Development. With the substantive support of the Eurasian Economic Commission, work continued with the Eurasian Intergovernmental Council's expert and analytical support. The closed discussions were attended by representatives of the academic community of Russia, EAEU countries and states – potential participants of free trade zones, business circles, employees of specialized agencies.

The main academic project of the year was RIAC's participation in writing the section, "Integration Processes in the Eurasian Space", as part of the XV Convention of the Russian International Studies Association, co-organized with the Department of Integration Processes of the Moscow State Institute of International Relations (MGIMO). The section summarized EAEU interim results of the year, outlined promising directions for further research of certain integration aspects; particularly, developing regional connectivity projects in the EAEU, improving food and agricultural cooperation, and raising awareness of the Union's activities. Participants assessed the Union's role in building the Greater Eurasian Partnership.

RUSSIA AND CHINA: PARTNERSHIP IN THE CONTEXT OF SECURITY CHALLENGES AND DEVELOPMENT IN THE ASIAN PACIFIC REGION (APR)

In 2023, amid global geopolitical competition and a transforming world order, China has continued to be one of Russia's key strategic partners.

In March 2023, a significant event for Russian-Chinese relations took place: President Xi Jinping arrived in Moscow on an official visit, which was his first trip abroad since his third term re-election. In September 2023, Russian President Vladimir Putin paid a return visit to Beijing during the third Belt and Road Initiative (BRI) forum. The dynamic development of Moscow and Beijing's relations is driven by a shared vision of the global order; a desire to see it more equitable, and mutual interest in stronger bilateral ties. These states have also become the main representatives for the interests of the Global South, promoting the positions of developing countries on the world agenda.

For the Russian International Affairs Council,

promoting Moscow and Beijing's common interests in the global arena, as well as Russian-Chinese economic cooperation and interaction in various regions of the world remained important in 2023. Special attention was paid to developing logistics and transportation inter-state cooperation in Greater Eurasia, including in conjunction with the Eurasian Economic Union (EAEU) and BRI, in terms of redistributing global production and supply chains.

Here, a central event in 2023 was the Eighth International Conference "Russia and China: Cooperation in a New Era," which RIAC yearly conducts with the Chinese Academy of Social Sciences (CASS). For the first time since the onslaught of the COVID-19 pandemic, the conference was held in Beijing last June. Cooperation with the Institute of International Studies (IIS) of Fudan University also resumed: an IIS delegation visited Moscow

to participate in the conference "Russian-Chinese Dialogue and International Order" last August.

Relations with new Chinese partners have been successfully developing; delegations from the Chinese Institutes of Contemporary International Relations (CICIR), the Economic and Social Council (ESC) of the People's Republic of China, and the CITIC Foundation for Reform and Development Studies had visited RIAC throughout the year. In addition, a joint roundtable with the Grandview Institution was held in October, which laid the foundation for further cooperation between the think tanks.

In terms of research, the results of Moscow and Beijing's cooperation in 2022-2023 were compre-

hensively analyzed by experts from RIAC, Fudan University and the Institute of China and Contemporary Asia (ICCA), Russian Academy of Sciences in the Ninth Annual Report, "Russia-China Dialogue: A Model for 2023". Prospects for deepening transport and logistics cooperation were separately discussed in the policy brief, "Development of Regional Connectivity in Eurasia: The Role of Russia and China in Establishing Transportation Routes on the Continent". A series of interviews with leading Chinese experts, timed to coincide with the visit of the PRC leader to Russia became a side project in 2023.

RUSSIA AND INDIA: TOWARDS A NEW AGENDA FOR BILATERAL RELATIONS

In 2023, Russia and India celebrated the 30th anniversary of the Treaty of Friendship and Cooperation. The fundamental principles enshrined in the document define the strong nature of the bilateral partnership and the similarities in state approaches to pressing global issues.

In the midst of ongoing pressure from Western countries, deepening Russian-Indian ties is a strategic priority for Moscow, since, on the one hand, it allows it to solve opportunistic economic problems associated with the need to minimize the impact of sanctions, and on the other hand, it contributes to the formation of an inclusive development model for countries of the global South. India is also a crucial partner in strengthening the multipolar world order and developing the Greater Eurasia macro-region. In 2023, additional opportunities for the realization of these tasks were generated due to India's chairmanship in the SCO and the G20.

RIAC's engagement with its Indian partners mainly focused on exploring current and future directions of bilateral ties in the altered economic environment. This project was aimed at deepening the existing partnerships with Indian experts and think tanks. The year started with an annual joint conference with the Indian Council of World Affairs (ICWA), which was held in person for the first time since the beginning of the COVID-19 pandemic. Two roundtables were held with Synergia Foundation on the political and economic dimension of Moscow and New Delhi's interactions.

SECURITY SYSTEM IN THE MIDDLE EAST

In 2023, the Middle East remained tense due to contradictions between regional players, as well as social and political instability in some countries.


Against this backdrop, RIAC's Middle East track prioritized the exploration of key regional political and economic trends. RIAC held a number of expert discussions with partner organizations from Iran, Turkey, Syria and China to explore current regional dynamics and other player views on the situation in the Middle East. The flagship publication within the Middle East track was RIAC's report "Regional Trends in the Middle East: Political and Economic Dynamics," authored by leading Russian orientalists. The report analyzed the overall regional dynamics in the Middle East and examined domestic political trends in Arab countries, Iran, Turkey and Israel.

The Russian Foreign Policy Concept adopted in 2023 notes that one of Russia's most important priorities in the Middle East is to promote the normalization of relations between the region's countries. Promoting possible improvements in 22

Syria-Turkey relations remains an urgent task. between Syria and Turkey remains an urgent task. RIAC has paid great attention to studying the prospects for Syrian-Turkish normalization. In 2023, a series of publications and events were prepared on various aspects of Syrian-Turkish relations. A key one was a quadrilateral meeting involving experts from Russia, Iran, Turkey and Syria, which focused on Ankara-Damascus relations.

RUSSIAN STRATEGY IN AFRICA

In its relations with African countries, the Russian Federation adheres to an approach that welcomes "African solutions to African problems". This aims to support the sovereignty of the continent's states and their freedom to choose how to promote their socio-economic and political development.

Russia's last two summits with African leaders and representatives demonstrates its return to the continent, and the intention to develop mutually beneficial cooperation with African states. As noted in the Declaration of the Second Russia-Africa Summit, Russia aims to "form a fairer, more balanced and sustainable multipolar world order, firmly opposing any form of international confrontation on the African continent".

The Second Russia-Africa Summit and the Russia-Africa Economic Forum held in Saint Petersburg in July 2023, demonstrated the transition from political agreements and defining general principles of cooperation with African nations, enshrined in the Declaration of the First Russia-Africa Summit in 2019, to the development of specific cooperation plans and implementation mechanisms until the next summit. It is expected that roadmaps will be signed, and projects in the energy sector, oil and gas, construction of nuclear power plants, geological exploration, fertilizer production and other areas will be developed.

The XV BRICS Summit, held in Johannesburg in August 2023, showed the growing geopoliti-

cal influence of the association, and revealed the growing interest of African countries in its activities. It was decided at the Summit to include two African states – Egypt and Ethiopia – demonstrating the activity of African nations and their desire to fully participate in building a multipolar world order.

The project's objective in 2023 was to study Russian-African cooperation in security and conflict resolution, as well as support Russia's understanding and image of its relationship with African nations. The role of BRICS in the emerging multipolar world, as well as the accession of new African countries within the organization was analyzed, along with the formation of a new agenda for Russian-African interaction in the association.

Collaboration with Russian think tanks and leading Africanists on issues facing the projecthave continued. The voting practices of Sub-Saharan African states in the UNGA have been studied. In preparation for the Second Russia-Africa Summit, the main directions of Russian-African cooperation between the summits and the interaction of the European Union and the United States with African nations during this period were analyzed.

Roundtables with ambassadors and representative offices of African embassies in the Russian Federation has continued to be an integral part of the project, discussing topical issues pertaining to Russian-African relations.

RUSSIA IN THE SOUTH CAUCASUS

The past year has seen historic changes in the South Caucasus. The main event was the end of the Nagorno-Karabakh conflict, which had lasted for more than 30 years. A unique window of opportunity has opened in the region to solve long-standing problems.

Armenia and Azerbaijan's official recognition of each other's territorial integrity, including the recognition of Nagorno-Karabakh as an integral part of Azerbaijan, as well as the decree on liquidating the Nagorno-Karabakh Republic and restoring Azerbaijan's territorial integrity and sovereignty over the Karabakh region, has opened a path towards the normalization of Armenian-Azerbaijani relations, the natural finale of which should be the signing of a peace treaty between Yerevan and Baku.

Project-wise, RIAC has organized expert seminars and roundtables jointly with think tanks from Azerbaijan and Armenia. The Council is interested in maintaining a dialogue with all partners in the region to develop objective views on the processes taking place in the South Caucasus and to discuss Russia's role in the region.

Expert meetings went on within the framework of the Russian-Azerbaijani Expert Council (RAEC), established at RIAC's initiative, as well as Azerbaijan's Center for Analysis of International Relations (CAIR). In 2023, two events were held within this format, to address the Russian-Azerbaijani strategic partnership based on the Moscow 2022 Declaration and Moscow-Baku's interaction following the end of the conflict in the South

Caucasus. A landmark event included the published edited volume, "Thirty Years of Diplomatic Relations between Russia and Azerbaijan: The Path Traveled and a Look into the Future", and its presentation by both foreign ministers at the third RAES meeting in February.

Cooperation with Armenian think tanks continued as well. Together with the NGO "Dialogue", a roundtable was held on how Russia and Armenia's national images are being perceived,

COOPERATION BETWEEN RUSSIA AND LATIN AMERICAN COUNTRIES IN THE NEW ENVIRONMENT

In 2023, a new direction focused on Latin America and the Caribbean saw rampant development at RIAC. The need to analyze the dynamics of external and internal factors of the countries in this region, as well as the prospects for the development of bilateral relations, is explained by the challenge of searching for new partners and deepening Russia's relations with existing ones.

According to the Russia's new Foreign Policy Concept, "the Russian Federation intends to develop relations with them (Latin American and Caribbean states) on a pragmatic, de-ideologized and mutually beneficial basis..."

One can note the increased interest in the region not only from the Russian government, but also from representatives of the business community, academia, and the expert community. The discussion topics cover limitations to the expansion of mutual trade, opportunities to lift these hurdles, as well as other promising areas.

Trade and economic issues were raised at a roundtable organized jointly with the Institute of Latin America, Russian Academy of Sciences. During the discussion, it was pointed out that it is necessary to place special emphasis on expanding trade cooperation in traditional areas where Russia's competitive advantages are obvious and

where there is a high demand for it in the Latin American market. It is also necessary to develop new logistical supply schemes through friendly country ports.

Experts discussed track-related projects, while representatives

of the country's leading universities presented their case studies on the implementation of joint scientific and technical projects with Latin American partners, emphasizing that they aim to deepen and strengthen scientific cooperation with Latin American nations.

INTERNATIONAL COOPERATION IN THE ARCTIC





RIAC continues its research highlighting cooperation and confrontation between different countries in the Arctic. The year 2023 was a year when the Arctic region once again has become seen as a field for deploying security and economic competition.

Security issues in the Arctic have become even more acute with the accession of Sweden and Finland (two Arctic states) to NATO.

As part of its Arctic project, RIAC is conducting expert and analytical work on the current status of the Arctic Council, its main areas of activity, and Russia's place and role in it. Special attention is also paid to the Asian dimension in the Arctic, taking into account the interest of states such as China and India in this region.

This year, the Council has prepared and presented analytical materials on the future of the Arctic Council and the results of Russia's chairmanship in this organization (2021–2023).

RUSSIA-WEST CONFRONTATION: POLICIES OF CERTAIN COUNTRIES AND RISKS OF ESCALATION

In 2023, Russia's relations with Western nations continued to deteriorate. Western countries have accelerated their push to build up their militaries. The United States and its allies are no less active in forming closed-end blocs in a number of regions. The confrontation between Russia and Western countries transpires not just in the military-political sphere but has become more hybrid in nature.

As international contradictions keep growing, the study of security issues in the Euro-Atlantic region, particularly those related to the termination of the INF Treaty, the actual suspension of the START-III, NATO expansion, the buildup of defense budgets by the NATO member states, etc., is of particular importance. In 2023, RIAC shifted the focus of its Euro-Atlantic studies to cover a military-political component. RIAC research projects have analyzed changes in the military and political potential of NATO member states, as well as an objective assessment of the current situation in the Euro-Atlantic region to forecast the possible escalation or de-escalation of relations between Russia and Western states militarily or politically.

RIAC is also covering the Balkans as part of its European project. The main trends in the region are the recurrent escalations in Kosovo, Russian-Serbian relations under pressure and Belgrade's refusal to implement sanctions against Moscow, as well as issues concerning Western Balkan state European integration. In this regard, RIAC initiated a round table concerning Kosovo, where experts discussed ways of managing escalation and possibilities for a peaceful conflict settlement in the future. Also, as part of the Council's expert and analytical activities, a working paper on the current aspects of Russian-Serbian relations in the current international environment was published. These studies have been designed to identify Russia's current position in the region,





analyze the possibilities for intensifying Russia's relations with Balkan states, and develop practical recommendations on the most pressing issues relating to their bilateral relations.

Within this project, RIAC also carries out expert and analytical work relating to the Baltic agenda. The key issues in the Baltic region in the current international environment are ensuring security and maintaining stability amid the growing "Atlanticization" of the region, as well as unfriendly actions taken by Baltic states. Equally important are the issues tied to economic and humanitarian cooperation between Russia and the EU in the midst of the geopolitical crisis. In this regard, RIAC, Saint Petersburg State University and the Kant Baltic Federal University initiated two expert workshops to discuss said aspects.

SANCTIONS AGAINST RUSSIA: AREAS OF ESCALATION AND COUNTERACTION POLICIES

The year 2023 was marked by the further intensification of Western sanctions pressure and the expansion of sanctions mechanisms used against Russia.

To date, Russia continues to be the greatest target of unilateral sanctions from foreign countries. The imposed restrictions have had a significant impact on all strategically important sectors of the Russian economy, including finance, energy, technology and other sectors. Within RIAC's sanction research projects, constant effort is made to study the structure of sanctions imposed on Russia, assess their impact on Russia's economic and technological potential, and analyze the measures taken to adapt to sanctions pressure and counteract it.

New trends in the sanctions policy of foreign countries have become a factor in expanding RIAC's research activities on a number of issues. In particular, one of the key areas is the study and analysis of the risks of secondary sanctions, as well as the administrative and criminal prosecution of Russian businesses and its citizens. RIAC shares its own expertise on these issues during specialized events. Expert seminars and briefings organized jointly with the Moscow Chamber of Commerce and Industry (MCCI), as well as Interfax Group's X-Compliance, often participate in these discussions.

RIAC continues to develop databases on sanction-related issues. Being an important methodological tool for analysis, sanction databases make it possible to trace the dynamics of sanctions policies pursued by foreign states, assess the role of agencies and parameters of decision-making on sanctions restrictions, as well as draw conclusions about potential methods of adapting to foreign sanctions and minimizing the risks for Russia. The analysis conducted using these databases have resulted in a number of research materials published on RIAC's website, in addition to key expert informational resources (Valdai, Profile, etc.) and in leading academic journals on international issues ("Polis", "Modern Europe", "International Analytics", etc.).

Cooperation with external experts, including lawyers, political scientists and economists specializing in the study of sanctions, is expanding and deepening. Thus, RIAC members and leading experts in the field of sanctions helped prepare and publish the Third Edition of the edited volume, "Sanctions Policy: Goals, Strategies, Tools." The practical value of the publication was appreciated both by representatives of the expert and academic community, as well as by specialized authorities and business organizations. Such research is in high demand among this target audience.

DEVELOPMENTING SCIENCE DIPLOMACY MECHANISMS AND TOOLS IN RUSSIA

Science diplomacy is the most promising area for interaction between countries, implying the use of certain tools in the field of scientific and technical cooperation.

In the modern-day, it seems necessary for Russia to develop this area and build mutually beneficial and constructive cooperation with partners from friendly nations, as it has experience in conducting large-scale joint international projects and has achieved significant success in finding new potential in developing its space, energy, agriculture and other spheres.

A key event in this track was the release of Report No. 90/2023, "Promising Areas for Scientific Cooperation: BRICS States", which focuses on BRICS models of science diplomacy, as well as general trends and prospects of multilateral scientific cooperation within BRICS. Based on the conceptual and institutional aspects of science diplomacy of Brazil, India, China and South Africa, and taking into account their potential and opportunities (bearing in mind their experiences in delivering various projects), the authors of the report formulated specific proposals and recommendations for the development of cooperation between Russia and the BRICS member states in scientific research.

DEVELOPING PUBLIC DIPLOMACY TOOLS IN RUSSIA

In 2023, RIAC continued to study foreign and Russian experiences in using various public diplomacy tools in order to develop recommendations on further developing this area in Russia, taking into account the current global geopolitical situation.

At the beginning of the year, the report, "Practices of Public Diplomacy in Russian Regions 2017-2021", prepared by experts of the Center for Support and Development of Public Initiatives – "Creative Diplomacy" at RIAC was presented. During the expert discussion, the participants noted that this study is one of the first and most significant steps in the field of public diplomacy. The authors were able to systematize a large amount of data and identify the most vulnerable spots in the current state of public diplomacy in their regions. As a result of the event, a briefing note was prepared, which, together with the report, was sent to the governors and heads of Russia's 85 constituent entities.

In November 2023, an expert discussion, "The Humanitarian Toolkit of Political Influence of World Actors in Central Asia and the South Caucasus" was held. The report, "The Politics of Influence of World Actors in Central Asia, Eastern Europe, the South Caucasus and the Baltic States" prepared by Rossotrudnichestvo's team, was used as a substantive basis for the discussion. During the expert debate, plenty of assessments of the research results and recommendations for further work were given. Special attention was paid to various methodological approaches. The experts emphasized the importance of such studies for the development of Russia's humanitarian policy in different regions of the world.

THE GREEN AGENDA: THE POLITICAL DIMENSION

After the COVID-19 pandemic and the energy crisis caused mainly by Western anti-Russan sanctions, attention towards green policies and climate change issues started to return to the agenda.

Today, the desire to preserve the Earth's climate can be used by states as a pretext for protectionist measures. For example, the European Union's Carbon Border Adjustment Mechanism (CBAM) has raised questions about its compatibility with WTO law, while the US Inflation Reduction Act of 2022 has even provoked friction with European allies over unfair competition practices. In addition to these economic complexities, there are also broad political tensions over climate change. Many traditional international structures are also beginning to put climate change on their agenda. Attempts to link climate change and security in the UN Security Council are particularly noteworthy. Russia opposes such attempts and insists on considering only the UN FCCC as the main climate negotiation process.

The crisis in relations with the West has not only created economic difficulties for Russia's green transition but has also contributed to reduced opportunities for dialogue in this area. However, Moscow continues to work on climate policy and

the green agenda with other states, particularly with nations of the Global South.

In 2023, RIAC continued to actively explore the global green agenda. In view of the changing geopolitical and geo-economic realities in the world, and the possibility of climate policy being used exclusively to promote national interests (especially by Western countries), RIAC has focused its research on achieving the goals of the Paris Agreement. Additionally, attention is given to cooperation between Russia and friendly countries in the climate field, and Russia's ability to achieve its own climate goals.

"We continue to consider the UN Framework Convention on Climate Change as the main intergovernmental discussion platform – this is written in our Foreign Policy Concept. At the same time, we are ready to interact with other countries in various formats, but this requires mutual willingness."

INTERNATIONAL MIGRATION: THE INSTITUTIONAL DIMENSION

Migration-related projects make up an important area of RIAC's activities. In the context of current global and regional trends, it seems particularly important to identify the most effective migration and human capital management practices for Russia.



In 2023, RIAC focused on examining key trends in demographic development and migration challenges. Special attention was paid to the current state of the labor market and how it is influenced by robotization and digitalization. These processes are increasingly affecting the labor market in Russia, modifying its structure and changing the demand for labor. In addition, RIAC paid attention to studying the main trends for external migration in the Russian Federation with a focus on educational and scientific migration to Russia, which retains potential for further development.

These topics were the focus of the IX International Conference, "Demographic Crisis and External Migration: Problems and Solutions" organized by RIAC and RANEPA. The conference was attended by Russian and foreign demographers and migration specialists.

NUCLEAR WEAPONS AND TECHNOLOGY IN CONTEMPORARY INTERNATIONAL RELATIONS

In 2023, the rapid degradation of a limited international arms regime continued. In the context of the nearly frozen strategic arms dialogues between Russia and the United States, the accelerated development of nuclear technology and capacity building in countries not included in the international system of arms reduction treaties continues. The risks of new additions to the nuclear powers list are also increasing, given the failure of the Iranian nuclear deal.

"Nuclear weapons ought to prevent not only nuclear war, but also conflicts between great powers. This is not happening now; for example, there is a high-intensity conflict raging between Russia and Ukraine, international sanctions have become commonplace, while the likelihood of a direct military clash between the United States and China keeps rising. New nuclear arms negotiations and new strategic stability are unlikely until a balance between the great powers is reached."

In this situation, it is increasingly important to analyze and consider the nuclear doctrines and approaches of those states that have previously received less attention from researchers. Among them, the Pakistan-India-China triangle stands out first and foremost. It is these nations that are most rapidly developing new strategic capabilities, while at the same time being in a state of acute confrontation with each other.

The arms race between the United States and China, which are not bound by treaties aimed at reducing the nuclear threat, is accelerating. The parties have been able to achieve the parity of their potential in all spheres, while in areas where such parity is impossible, they leverage technological breakthroughs to make up for a lag.

In the debut year of this RIAC project, a working paper titled "American Nuclear Doctrine: Key Stages of Development and Principles of Operation" was prepared and analyzed key milestones and principles of American nuclear doctrine developments from 1945 to date. The roundtable, "Strategic Stability in South Asia: Regional Security and Global Implications", was also held jointly with the Pakistani think tank SVI on global and regional trends in strategic stability.

INTERNATIONAL DIMENSION OF TECHNOLOGY-RELATED POLICIES

Today, humanity is experiencing a complex period of throes as it gives birth not only to a multipolar world order, but also to a new technological mode, accompanied by intensified competition between different nations, including in technological leadership. Technology is moving to the geopolitical plane and is acquiring strategic importance. Overall, technological dominance will play an important role in determining the future world order.

In order to survive these turbulent times, with established supply chains collapsing and globalization winding down, the issue of being technologically self-sufficient becomes crucial for the majority of actors in international relations. The demand for techno-nationalism arises once again. However, because the high-tech industry has been developing due to global labor divisions, technological sovereignty may soon reach its limits – no country today can achieve import substitution for an entire production chain. In this regard, international cooperation in scientific and technological spheres is of particular importance.

ELECTRONIC INTERNATIONALIZATION OF RUSSIAN UNIVERSITIES

In a modern environment, the promotion of Russian education and science on foreign markets, as well as the attraction of foreign students and scientific personnel, is impossible without the use of digital resources and technology.

Today, English-language websites of Russian universities are one of the main channels that may aid their international positioning, given the restrictions on domestic universities with popular social networks, as well as on their presence on foreign educational resources and in world rankings.

In 2023, RIAC published the results of a new stage of research on English-language Internet resources of Russian universities as part of Report No. 88/2023 "Electronic Internationalization: English-Language Internet Resources of Russian Universities" (2023). The first chapter presents an updated rating of English-language websites of Russian universities, analyzes typical problems and gives recommendations for their solution. The second chapter contains a survey of employees of international services from Russian universities, identifying the stimulating and restraining factors of e-internationalization development in Russian universities. Based on the data obtained, it was analyzed how the model of e-internationalization management had changed in recent years, internal problems were identified and the best practices of e-internationalization management in a period of digital constraints were named.

"E-internationalization involves creating and maintaining multilingual versions of university websites to give students from different countries access to information in their own language. Since English is the language of international communication and the first foreign language for most students, it is extremely important for universities to create websites in this language. Nowadays, an urgent task for universities is to create a Chinese version of the resource, which could be instrumental in reaching a wide audience of students and applicants by providing them with necessary and interesting information."

English-Language Internet Resources of Russian Universities 2023", November 14, 2023)

In the context of suspended cooperation with traditional partners, the urgent goals for Russian tertiary education are to enter and advance in underexplored or new foreign markets. Taking into account the significant role assigned to the development of cooperation with China and India, the current report analyzes the factors that foreign



students from these countries pay special attention to when enrolling in Russian universities, as well as to the problems they face when searching for necessary information and communicating with university staff.

In order to identify the most significant factors influencing the final decision when enrolling in Russian universities, RIAC and the Ministry of Science and Higher Education of the Russian Federation, conducted a survey of over 5,000 Chinese and Indian students studying at Russian universities. A review of the responses received, and the proposed recommendations will help Russian higher education institutions strengthen their strategy for attracting foreign students.

This report was presented at the Moscow City Pedagogical University as part of the roundtable, "University Positions in the Internet Space and their Reorientation to Chinese and Indian Educational Markets". During the discussion, experts focused on a number of issues related to the efficiency of using digital resources for the implementation of international activities, as well as existing problems and best practices of e-internationalization.



RIAC is also focused on the current challenges and problems of Russian scientific research. At the turn of the year, RIAC and the National Research University - Higher School of Economics (HSE) organized an expert seminar, "The Issues of Promoting Russian Science in International Markets". During discussion, proposals were made to update the Concept of Scientific and Technological Cooperation of the Russian Federation and to prioritize mutually beneficial international scientific and technical cooperation with various countries, both in fundamental and applied research and developments.

The first stage of RIAC's joint projects in 2023 included completed research with the E.M. Primakov Institute of World Economy and International Relations (IMEMO), Russian Academy of Sciences, and the journal World Economy and International Relations.

Two seminars were held to highlight the role of the African continent in global politics and the problem of scientific and technological leadership in the context of growing global competition. In 2021-2023, a series of scientific and practical seminars organized by RIAC, IMEMO and WE&IR to study current problems in international relations, and share experiences in applying empirical methods and fundamental theories aroused the interest of a broad and professional audience. The openness of the format, the variety of topics, and the high level of experts became a hallmark of the project. Analytical reviews based on the results of the seminars were published in *World Economy and International Relations*.

In 2024, the joint projects will be continued. The second cycle of seminars is planned, this time focusing on Russia's foreign policy in a changed environment.

INTERNSHIPS

In 2023, over 100 students from Russian universities (Lomonosov Moscow State University, Moscow State Institute of International Relations (MGIMO), National Research University - Higher School of Economics, Russian State Saint PetersburgFar Eastern Federal Diplomatic Academy of the Russian Ministry of Foreign Affairs, etc.) and from universities of other countries have completed an internship at RIAC. It is noteworthy that among the Russian trainees, there were students representing universities from different parts of the country. After the COVID-19 pandemic, RIAC developed and improved its remote internships, which seems to be important for interns from foreign and domestic regional faroff universities.

Students interning at RIAC have the opportunity to become involved in the Council's projects in areas that interest them. The internship includes both participation in ongoing project activities (preparing events, searching for information, compiling databases) and working on their own texts and research projects under the guidance of a supervisor. RIAC internships are supervised by program managers and coordinators.

In 2023, RIAC expanded its network of future international experts and continues to maintain social media accounts for graduates of the Council's internship program. Information about interns, their research interests and publications, and the work they have done is published on the Council's website.

In 2023, RIAC organized a number of events targeting a wider audience, from specialized experts to young professionals, students and anyone interested in international relations.

RIAC's Urbi et Orbi City Breakfasts traditionally co-opted a rich palette of topics: experts discussed the contours of Eurasian integration and the prospects for BRICS enlargement, the role of Africa in world politics and the bundles of contradictions in the Middle East, as well as the image of Russia's future and its foreign policy present. City breakfasts remain a strong magnet for specialists and those interested in international relations. More and more listeners take the opportunity to communicate directly with leading experts on various international issues, while the discussions, maintaining a high professional level year after year, can serve as a model for public debate of the most pressing topics.

RIAC continued to participate in the annual non/fiction book fairs. RIAC's stand, which reflected its publication activity over the past few years, attracted the interest of hundreds of readers, who noted the high informative level of RIAC's analytical materials.

PODCASTS

In 2023, the Russian International Affairs Council continued to develop its podcasts.

As part of the new issues, RIAC specialists conducted interviews with leading Russian experts on international relations in a number of areas. Russia's bilateral cooperation in the new environment, as well as the relevant events on the international agenda, took an important place among the topics discussed.

The involvement of non-Arctic states in the activities and development of projects in the Arctic region, accompanied by cooperation with Western nations being frozen showed the importance of discussing key trends in building Russian-Chinese and Russian-Indian relations in the Arctic. Russia's chairmanship of BRICS in 2024 was a good occasion to consider potential formats of cooperation between forum participants in the Arctic region.

The grave humanitarian situation in Syria, resulting from the ongoing military operations in the country and aggravated by the consequences of natural disasters, predetermined the need to assess the prospects for the settlement of Syrian-Turkish contradictions, as well as the opportunities for the country to overcome the economic and humanitarian crisis along with its potential for emerging as an independent player in the region.

The ongoing technological confrontation between the US and China, along with global trends toward technological sovereignty, was an equally high-priority topic for discussion. Within the framework of the above-mentioned agenda, experts paid much attention to issues related to China's emergence as a technological superpower, the outlook for the formation of a bipolar system in the high-tech sphere, as well as the possibilities of creating interstate technological alliances.






RIAC's website retains its position as one of the most popular and in-demand Russian online resources in the field of international relations. In 2023, the average monthly audience exceeded 2.5 million users, which is almost 70% higher than the previous year's figures.

In 2023, the audience growth rates continued following 2022, part due to the large attraction of a broader Russian public to expert and academic analytical research amid an aggravated international situation.

The website's audience continues to be dominated by the "student segment" in the age group of 18 to 24 – over 32%. Pleasingly notable is that as the audience grows older, it stays with RIAC – the share of the audience aged 25-34 is steadily growing and amounts to 23%.

In 2023, the share of the Russian audience continued to grow – 65.4% versus 63.2% a year before, followed by the US audience, which ranks second, contributing to almost 13% of all website visits.






